#### **GOAL OF TREATMENTS AT END-OF-LIFE**

- Promote comfort
- Prevent or relieve suffering
- Respect patient's wishes



#### 3 main goals- need to prioritize

#### Continue or expand life-prolonging treatments with goal of:






#### **Anatomy of Current Discussions**

#### Usually receives MOST (or all) attention









#### Mr. D



85 year old LTC resident with: hypertension, Alzheimer's dementia, Type 2 DM

- Has been in your facility for 3 years
- Developed heart failure and has had 3 hospitalizations in the past 3 months due to dyspnea
- You have a great relationship with his wife who is his medical POA
- He does not have capacity
- He's returned to your facility with skilled needs after this most recent hospitalization



#### What do you do FIRST during this re-admission?

- A. Review discharge summary
- **B.** Review medications
- c. Talk with his wife

#### What do you ask his wife (mPOA) first?

- A. What do you want to do?
- B. Do you have any questions?
- c. What is your understanding of his current medical condition?
- D. What should his code status be?





### After review of records and exam you find the following: Function status has worsened

- Previously he could feed himself and sit up in a chair
- Currently –needs to be fed (he is still able to swallow)
- Short of breath when moving from bed to wheelchair
- EF is now 15%
- Meds
  - Lasix 80 mg BID
  - Metopolol 25 mg BID
  - Not on ACE (cannot tolerate)
  - Atorvastatin 40 mg QDay
- Has edema in his bilateral LE (this is new)


### You've had discussions with his wife in the past. You know that her goal for him is:

#### COVID-19: Data, Treatment, Vaccines


Cases in some areas trending up. No new therapeutics. Vaccination guidance page updated 7/17/23: 1 updated vaccine and if >65, a second dose 4 months after.

#### COVID 19 burden in Virginia LTC facilities

In the month of July there were <u>55 COVID-19 outbreaks</u> reported from Virginia LTC facilities. So far in August, there have been 31 COVID-19 outbreaks reported from Virginia long-term care facilities, including 11 from assisted living facilities, 12 from nursing homes, and 8 from multicare facilities <u>Virginia Department of Health (VDH)</u> <u>COVID-19 Dashboards</u>

Vaccines are still free of charge to recipients (no charge or copay), but can seek reimbursement from private insurance, Medicare or Medicaid.
